## MINUTES SUMMERFIELD TOWNSHIP PLANNING COMMISSION SEPTEMBER 11, 2023

## **OLD BUSINESS:**

1. Continuation of Broadway Open Space Preservation Special Use Application Public Hearing.

Chairperson Amy Reiter reopened the Public Hearing at 7:02 p.m. The Broadways were present and submitted amendments to their covenants pursuant to the Township attorney's recommendations. A revised site plan was provided clearly showing 100' of frontage on the rear lot. Having been satisfied that the recommendations were followed and without objection from the Planning Commission members, Chairperson Amy Reiter moved to recommend adoption of the Open Space Preservation application to the Summerfield Township Board with the following provisions:

- 1. Waiving the ordinance mandate of a 150' buffer area from Teal Road as the topography of the property has an existing buffer.
- 2. The required submission of a parallel plan shall be waived since the number of housing units proposed in the open space preservation project is without question below what would be feasible for the site.

The motion was seconded by Joe Stanger and unanimously approved.

The Public Hearing was closed at 7:08 p.m.

1. <u>Elect Chair and Vice Chair/Secretary</u> - The election of Chairperson, Vice Chairperson and Secretary for the coming year came before the Commission.
