Transferred \$10,000 from the ARPA account for earnest money for the purchase of the bank. Total monies in all accounts are \$4,076,314.96. Motion by Seegert and supported by Strahan to accept the Treasurer's Report. Motion carried.

<u>Pay Bills:</u> Clerk Goodin presented checks. Motion by Seegert and supported by Strahan to pay checks #34208-#34261 in the amount of \$213,320.96. Motion carried.

New Business:

- a) Cemetery Mowing Bids Two sealed bids were received. One was from Cress Tree Service and one was from JP Lawn Care & More. Both bids were \$55,000. After much discussion, a motion was made by Seegert and supported by Strahan to hire Cress Tree Service. Roll call vote: Wiederhold-yea, Strahan-yea, Seegert-(after rescinding his abstention) nay, Goodin-nay and Lucarelli-nay. Motion failed.
 - Motion by Seegert and supported by Strahan to hire JP Lawn Care & More at the bid of \$55,000. Roll call vote: 5 yeas, 0 nays. Motion carried.
- b) Fire Mowing Specs Motion by Strahan and supported by Seegert to have Cress Tree Service continue the mowing and trimming at the fire hall with the current terms. Motion

carried. Trustee Strahan asked Jordan Cress if he would look at the bushes at the bank and give us a quote for trimming them in the future.
