## NOTICE TO APPLICANT:

Request for Sign Permit will be reviewed by the Planning Commission <u>after submission</u> <u>through the Summerfield Township Building Inspector</u>. Application shall be submitted to the Building Inspector with the following accompanying information:

- A. Drawings showing the design, location, content and dimensions of the sign(s);
- B. The design and dimensions of any measures used to support the sign(s) or used to affix the sign(s) to a wall, window or the ground.

In a development containing several buildings or businesses, also required is:

- C. A common signage plan consisting of:
  - 1. Location: identification of sign locations on buildings or property.
- 2. Materials: description of the type of sign and sign materials including construction materials and proposed lighting, if any.
  - 3. Size: itemization of sign size or band area at identified locations.
- 4. (a) Letter style: description of dominant letter style and letter height to be used on the signs.
- (b) Color: listing of the colors to be used on each sign. A maximum of 3 colors are allowed in a single common plan. Any neon lighting for building signage must be matched to an approved color specified on the signage plan in order to be included as part of the color scheme.
- (c) Where more than one sign is located on a property or where more than one building or business is located in a single development project, such as a shopping center, the common signage plan will demonstrate that these elements create consistency and uniformity among signs within the project.
- (d) Minor alterations in sign locations resulting from unexpected conditions on site may be approved by the Building Inspector.

NOTE: Temporary signs do NOT require a signage plan; however, A and B do apply.
